

Terms and Conditions for Stadium Football Events

This Contract (as defined below) sets out the Conditions under which we will provide the Service (as defined below) to you.

By "you" or "your" we mean the "Customer" as defined below.

By "us" and "we" we mean Play With A Legend Limited, a company registered in England and Wales under Company number 08938799 and having its registered office at 7 Holders Hill Drive, London, NW4 1NL ("Play With A Legend" or "PWAL").

Meaning of Terms

In this Contract (unless the Contract otherwise requires), the following words shall have the following meanings:

Booking means the request and confirmation of the Service (in the form of a Receipt). **Booking Form** means the form filled out by the Customer on PWAL's website in which the Customer's request for a Booking is made.

Customer means any person making a Booking (whether they are the Player or not). **Conditions** means these terms and conditions, as amended from time to time by PWAL. **Contract** means these Conditions, along with the Booking Form, Receipt and the Picelaimer.

Date means the date of the Match as specified on the Receipt.

Disclaimer means the event disclaimer which all Players must sign before they take part in the Match.

Match means the football match for which the Booking has been made.

Legend means an ex-footballer whose has agreed to take part in Matches organised by PWAL.

Player means any person taking part in a Match as a result of a Booking being made on their behalf.

Price means the price specified on the Booking Form.

Receipt means the confirmation provided by PWAL that payment has been received and consequently a Booking has been completed, setting out the details of the Match, Date, Venue and Legends.

Referee means the individual who will officiate the Match.

Service means the services as provided by PWAL as set out in the Contract.

Stadium Football Event or **Event** means a Match organised by PWAL to take place at a specific Venue, on a specific Date, where Players can play alongside Legends.

Venue means the location of the Match as set out in the Receipt.



Bookings

- 1. A Booking is confirmed only when a Customer has:
 - a. Filled in the Booking Form on PWAL's website, AND
 - b. Made full payment for the Service, AND
 - c. Confirmed they have read and agree to these terms and conditions; AND
 - d. Been issued with a Receipt by PWAL.
- 2. A Deposit Payment can be made to open a booking, but the booking is not confirmed until full payment is made.
- 3. PWAL are under no obligation to offer a refund of any Deposit Payments, notwithstanding any specific circumstances set out below.
- 4. Once full payment has been made for the Service, PWAL are under no obligation to offer any refund whatsoever, notwithstanding any specific circumstances set out below.
- 5. A confirmed Booking has the effect of reserving a place for the Customer to play in the Match in the position and for the duration specified in the Contract.
- 6. At any time, a Customer is free to pass their place in the Match on to someone else provided they are male and over the age of 18, who will consequently become the Player. The Contract will remain between PWAL and the Customer whether the Customer is the Player or not.
- 7. The Customer must inform PWAL in advance of the Match if they are not going to be the Player and provide PWAL with the Player's details.
- 8. It is the Customer's responsibility to ensure that the Player fulfils any obligation that arises out of the Contract.

PWAL's Obligations

- 9. PWAL will arrange the Stadium Football Event.
- 10. The full details of the Booking will be found on the Receipt. A full itinerary will be sent out 28 days prior to the Match.
- 11. PWAL will provide Players with the following kit which must be worn during the Match:
 - a. Shirt with your surname printed on the back;
 - b. Shorts;
 - c. Socks:
- 12. The number on the back of each Player's shirt will be allocated on the basis of their intended position on the field as indicated on the Booking form pertaining to their participation.
- 13. PWAL will organise for the Match to be officiated by a Referee.

The Player's Obligations

14. All Players must sign the Disclaimer prior to the start of the Match.



- 15. Players must bring their own football boots that are appropriate for playing on grass. The Player will not be allowed to play if the Referee deems their footwear to be inappropriate. No refund will be offered in these circumstances.
- 16. Players must bring appropriate shin pads and must wear them for the duration of the Match.
- 17. Towels will not be provided by PWAL and therefore it is recommended that all Players bring their own so they can shower after the Match.
- 18. Referees will referee the game in such a way that reflects their responsibility to protect and safeguard all Players, Legends and spectators. To that end, if a Referee issues a Player with a red card during the duration of the Match, the player will not be allowed to return to the field of play and no refund will be offered.

Legends

19. The Legends listed on the Booking Form and/or Receipt are Legends that have agreed with PWAL to play in the Match. In the unlikely event that the Legend due to play in your Match is forced to cancel due to injury or any other circumstance outside of our control, then PWAL will replace them with another Legend.

Venue Cancellation

- 20. The Venue has reserved the right to cancel the Match with 21 days notice.
- 21. In the very unlikely event that this happens, PWAL will issue a full refund to the Customer.
- 22. PWAL is not liable for any further losses incurred by the Customer in the event of a Venue Cancellation.

Insurance

- 23. PWAL has arranged Public Liability Insurance for all our Matches.
- 24. First aid will be arranged by the Venue.
- 25. Personal Injury Insurance is not provided. All Players take part at their own risk subject to the contents of the Disclaimer.

By stating your agreement to these terms and conditions on the Booking Form, it means that you have read and understood them and intend to abide by them.
